stock trading plan effective November 8, 2004, in accordance with Rule 10b5-1 promulgated under the Securities Exchange Act of 1934. Mr. Mack entered into this plan during an open trading period under Inforte's insider trading policy. The plan provides for sales, by a combination of market and limit orders, of up to 400,000 shares of the Company's common stock in specified share amounts at market prices, subject to specified limitations. Sales pursuant to this plan will commence on or after November 22, 2004 and will end on or before November 18, 2005 and will be publicly disclosed through Form 144 and Form 4 filings with the Securities and Exchange Commission as required. Except as may be required by law, Inforte does not undertake to report modifications, terminations or other activities under Mr. Mack's plan.
