- (1) The original Form 5 filed on May 10, 2005, noted that on December 30, 2004, Grenma, Inc. transferred by gift 114,666 shares of Common Stock to a charitable trust. This statement was incorrect. On December 30, 2004, Ingrid T. Mahan, the sole shareholder of Grenma, Inc., transferred all of the outstanding equity of Grenma, Inc. to a charitable trust, of which she is the donor and one of three trustees. At the time of such transfer, Grenma, Inc. was the owner of 114,666 shares of Common Stock (based on pre-split numbers).
