As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert

- (1) automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation. This disposition of the shares of Class B Common Stock by the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation.

- (2) The Form 4, as originally filed on June 5, 2017, characterized the transfer of shares by the Reporting Person to Tao Invest LLC as a sale to Tao Invest LLC. In fact, the shares were transferred to a division of Tao Invest LLC, and the Reporting Person retains a pecuniary interest in the shares as well as voting and dispositive powers with respect to the shares.
