("Empire Capital"), with respect to the 3,150,540 shares, Empire Capital Partners, Ltd., a Cayman Islands exempted company ("Offshore") as to 2,847,368 shares, Empire Capital Partners II, Ltd., a Cayman Islands exempted company ("Offshore II") as to 527,781 shares, Charter Oak Partners, LP, a Delaware Limited Partnership ("Charter Oak") as to 952,000 shares and Charter Oak Partners II ("Charter Oak II" and collectively with Empire Capital, Offshore, Offshore II, and Charter Oak, the "Empire Funds") as to 113,870 shares of Common Stock directly owned by it.
