Item 8.01                    Other Events.

On January 5, 2010, Peapack-Gladstone Financial Corporation (the “Corporation”) announced that it received approval from the U.S. Department of the Treasury (the “Treasury”) for its request to redeem 25% of the Corporation’s Fixed Rate Cumulative Perpetual Preferred Stock, Series A (the “Preferred Shares”), issued to the Treasury pursuant to the Troubled Asset Relief Program Capital Purchase Program. On January 6, 2010, the Corporation expects to pay approximately \$7.2 million to the Treasury to repurchase the Preferred Shares, including accrued and unpaid dividends for such shares. The Corporation’s redemption of the Preferred Shares is not subject to additional conditions or stipulations from the Treasury. A copy of the press release is attached hereto as Exhibit 99 and is incorporated herein by reference.
