On March 9, 2006, Alabama Power Company (the Company) entered into an Underwriting Agreement covering the issue and sale by the Company of \$200,000,000 aggregate principal amount of its Series II 5.875% Senior Notes due March 15, 2046 (the Series II Senior Notes). The Series II Senior Notes were registered under the Securities Act of 1933, as amended, pursuant to the shelf registration statement (Registration Nos. 333-126348, 333-126348-01, 333-126348-02 and 333-126348-03) of the Company.
