- On January 19, 2007, the Issuer declared a stock dividend, payable to all holders of record of Class A and Class B Common Stock on March 23, 2007, of .05 shares of Class A and Class B Common Stock, respectively, for each share of Class A and Class B Common Stock outstanding.
- (1) Includes 771.7147 shares of Class A Common Stock allocated to the reporting person under the ESOP, based on information provided by the plan administrator.
