As of February 10, 2006, Select and Select Offshore are the beneficial owners of 7,579,818 shares of Common Stock of O'Reilly Automotive, Inc. ("Common Stock"), for a total beneficial ownership of 6.76% of the outstanding shares of Common Stock.
