CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 70,235,590 shares or 9.4% of the 747,569,359 shares of Ordinary Shares, including American Depositary Shares, believed to be outstanding.

Capital International Limited is deemed to be the beneficial owner of 42,005,070 shares or 5.6% of the 747,569,359 shares of Ordinary Shares, including American Depositary Shares, believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.
