Following the Annual Meeting of Shareholders of Canadian National Railway Company (the "Company") held on Tuesday, April 27, 2010, at 10:00 a.m., (Eastern Daylight Time) at Le Windsor, 1170 Peel Street, Montréal, Quebec, Canada (the "Meeting"), and in accordance with section



11.3 of NI 51-102 – Continuous Disclosure Obligations, we hereby advise you of the following voting results obtained at the Meeting.

#### 1. Election of Directors

A ballot was conducted with respect to the election of directors. The 11 nominees proposed by management were elected as directors. According to proxies received and ballots cast, each of the following 11 individuals were elected as directors of the Company until the next annual shareholder meeting or until such person's successor is elected or appointed, with the following results:
