Preliminary Terms

Issuer: Citigroup Global Markets Holdings Inc.

Guarantee: All payments due on the securities are fully and unconditionally guaranteed by Citigroup Inc.

Underlyings: The S&P 500® Index and the Russell 2000® Index

Stated

principal amount: \$1,000 per security

Pricing date: March 29, 2019

Issue date: April 3, 2019

Valuation dates: March 30, 2020, March 29, 2021, March 29, 2022, March 29, 2023 and April 1, 2024 (the “final valuation date”)

Automatic early

redemption: If, on any valuation date prior to the final valuation date, the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the fifth business day immediately following that valuation date for an amount in cash per security equal to \$1,000 plus the premium applicable to that valuation date. If the securities are automatically redeemed following any valuation date prior to the final valuation date, they will cease to be outstanding and you will not receive the premium applicable to any later valuation date.

Premium: The premium applicable to each valuation date will be determined on the pricing date and will be within the ranges indicated below. **The premium may be significantly less than the appreciation of any underlying from the pricing date to the applicable valuation date.**

- March 30, 2020: 9.25% to 10.25% of the stated principal amount
- March 29, 2021: 18.50% to 20.50% of the stated principal amount
- March 29, 2022: 27.75% to 30.75% of the stated principal amount
- March 29, 2023: 37.00% to 41.00% of the stated principal amount
- April 1, 2024: 46.25% to 51.25% of the stated principal amount

Maturity date: Unless earlier redeemed, April 4, 2024

Underlying return: For each underlying on any valuation date, (i) its closing value on that valuation date *minus* its initial underlying value, *divided by* (ii) its initial underlying value

Trigger value: For each underlying, 60% of its initial underlying value

Payment at Maturity: If the securities are not automatically redeemed prior to maturity, you will receive at maturity, for each security you then hold, an amount in cash equal to:

§ If the final underlying value of the worst performing underlying on the final valuation date is **greater than or equal to** its initial underlying value:

\$1,000 + the premium applicable to the final valuation date

§ If the final underlying value of the worst performing underlying on the final valuation date is **less than** its initial underlying value but **greater than or equal to** its trigger value: \$1,000

§ If the final underlying value of the worst performing underlying on the final valuation date is **less than** its trigger value:

\$1,000 + (\$1,000 × the underlying return of the worst performing underlying on the final valuation date)

If the securities are not automatically redeemed prior to maturity and the final underlying value of the worst performing underlying on the final valuation date is less than its trigger value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity. The securities are unsecured debt securities. All payments on the securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.

The table below illustrates how the amount payable per security will be calculated if the closing value of the worst performing underlying on any valuation date (other than the final valuation date) is greater than or equal to the applicable premium threshold:

Hypothetical Payout Table*

If the first valuation date on which the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value is then you will receive the following payment per \$1,000 security upon automatic early redemption or at maturity, as applicable:
March 30, 2020	$\$1,000 + \text{applicable premium} = \$1,000 + \$92.50 = \$1,092.50$
March 29, 2021	$\$1,000 + \text{applicable premium} = \$1,000 + \$185.00 = \$1,185.00$
March 29, 2022	$\$1,000 + \text{applicable premium} = \$1,000 + \$277.50 = \$1,277.50$
March 29, 2023	$\$1,000 + \text{applicable premium} = \$1,000 + \$370.00 = \$1,370.00$
April 1, 2024	$\$1,000 + \text{applicable premium} = \$1,000 + \$462.50 = \$1,462.50$

Selected Risk Considerations

- You may lose a significant portion or all of your investment.
