AMENDMENT NO. 4 TO SCHEDULE 13D
RELATING TO THE COMMON SHARES OF BENEFICIAL INTEREST OF
PRIME GROUP REALTY TRUST

Vornado Realty Trust ("Vornado"), Vornado Realty L.P. (the "Operating Partnership") and Vornado PS, L.L.C. ("Vornado PS" and, collectively with Vornado and the Operating Partnership, the "Reporting Persons") hereby amend their Statement on Schedule 13D filed with respect to the Common Shares of Beneficial Interest, par value \$0.01 per share ("Common Shares"), of Prime Group Realty Trust, a Maryland real estate investment trust (the "Issuer"). This Amendment No. 4 to Schedule 13D ("Amendment No. 4") should be read in conjunction with the Statement on Schedule 13D of the Reporting Persons filed on November 2, 2001 (the "Initial Schedule 13D"), as amended by Amendment No. 1 to Schedule 13D of the Reporting Persons filed on November 20, 2001, by Amendment No. 2 to Schedule 13D of the Reporting Persons filed on December 19, 2001 and by Amendment No. 3 to Schedule 13D of the Reporting Persons filed on December 21, 2001 (as so amended, the "Schedule 13D"). This Amendment No. 4 amends the Schedule 13D only with respect to the items listed below. Unless otherwise indicated, all capitalized terms used but not defined herein shall have the meaning ascribed to them in the Initial Schedule 13D.

Pursuant to Rule 13d-4 under the Exchange Act, each of the Reporting Persons declares that the filing of this statement shall not be construed as an

admission that such Reporting Person is, for the purposes of Section 13(d) or 13(g) of the Exchange Act, the beneficial owner of any Common Shares.

Any disclosures made herein with respect to persons other than the Reporting Persons are made on information and belief after making appropriate inquiry.

Item 4. Purpose of the Transaction.

Item 4 is hereby amended by replacing the sentence that read "Vornado PS expects to conduct the Foreclosure Auction on or about January 9, 2002" with "Vornado PS currently expects to conduct the Foreclosure Auction on or about January 22, 2002" and by adding the following paragraph at the end of Item 4:

According to Amendment No. 9 to the Schedule 13D of Michael W. Reschke, Primestone Investment Partners L.P., PG/Primestone, L.L.C. and The Prime Group, Inc. filed on December 21, 2001, the Borrower intends to appeal the dismissal of its bankruptcy petition and to request that the automatic stay be reinstated pending appeal. On December 21 Primestone filed a motion with the Bankruptcy Court seeking a stay of the order dismissing Primestone's bankruptcy case pending an appeal from that order. The Bankruptcy Court denied the motion on December 27.

Item 5. Interest in Securities of the Issuer.

Item 5 is hereby amended by adding the following sentence at the end of paragraph (c) thereof:

No transactions in the Common Shares were effected by Reporting Persons since December 21, 2001, except to the extent that such transactions may be deemed to have occurred as described in Item 4.
