AMENDMENT NO. 2 TO SCHEDULE 13G

This Amendment No. 2 to Schedule 13G (the "Schedule 13G"), relating to shares of common stock of Stage Stores, Inc., a Nevada corporation (the "Issuer"), is being filed with the Securities and Exchange Commission (the "Commission") as an amendment to Schedule 13G filed with the Commission on February 14, 2002, as amended by Amendment No. 1, filed with the Commission on October 15, 2002. This Schedule 13G is being filed on behalf of Greenlight Capital, L.L.C., a Delaware limited liability company ("Greenlight"), and Mr. David Einhorn, principal of Greenlight.

This Schedule 13G relates to shares of Common Stock of the Issuer purchased by Greenlight for the account of (i) Greenlight Capital, L.P. ("Greenlight Fund"), of which Greenlight is the general partner, (ii) Greenlight Capital Qualified, L.P. ("Greenlight Qualified"), of which Greenlight is the general partner and (iii) Greenlight Capital Offshore, Ltd. ("Greenlight

Offshore"), to which Greenlight acts as investment advisor.

ITEM 2(a) NAME OF PERSON FILING.

Greenlight and David Einhorn

ITEM 2(c) CITIZENSHIP OR PLACE OF ORGANIZATION.

Greenlight is a limited liability company organized under the laws of the State of Delaware. David Einhorn is the principal of Greenlight and a United States citizen.

ITEM 4 OWNERSHIP.

(a) Greenlight and Mr. Einhorn are the beneficial owners of 2,254,100 shares of Common Stock.

(b) Greenlight and Mr. Einhorn are the beneficial owners of 11.9% of the outstanding shares of Common Stock. This percentage is determined by dividing 2,254,100 by 18,899,650, the number of shares of Common Stock issued and outstanding as of December 12, 2002, as reported in an amendment to the Issuer's quarterly report on Form 10-Q/A filed on December 18, 2002.

(c) Greenlight has the sole power to vote and dispose of the 2,254,100 shares of Common Stock beneficially owned by it. As the principal of Greenlight, Mr. Einhorn may direct the vote and disposition of the 2,254,100 shares of Common Stock beneficially owned by Greenlight.

ITEM 10 CERTIFICATION.

By signing below I certify that, to the best of my knowledge and belief, the securities referred to above were not acquired and are not held for the purpose of or with the effect of changing or influencing the control of the issuer of the securities and were
