("Cantor") acted as underwriter with respect to the sales pursuant to a sales agreement dated September 16, 2004 between us, First Industrial, L.P. and Cantor (the "Sales Agreement"). The Sales Agreement has been filed as an exhibit to our current report on Form 8-K filed with the Securities and Exchange Commission (the "Commission") on September 16, 2004 and is incorporated by reference herein and in the accompanying prospectus dated August 30, 2004.
